15 YEAR LIMITED WARRANTY

For a period of two (2) years from the original purchase date, Z-FLEX warrants this venting system to be free from defects in material and workmanship under normal use and service, subject to the terms and conditions in this Limited Warranty. This Limited Warranty shall extend to the original purchaser of this venting system or, if purchased by a contractor, to the original end user. During this period Z-FLEX agrees to replace such defective components without charge (exclusive of removal and/or installation costs). This warranty shall continue for an additional thirteen (13) years on a pro-rated basis with the original purchaser or end user responsible for the pro-rated portion of the value of the replacement components, such

pro-ration commencing with the original purchase date.

In order for this Limited Warranty to remain in effect, this product and the related heating system(s) shall be installed in accordance with the approved installation instructions. This Limited Warranty covers only the specific manufacturing defects described herein and excludes any other damages or material failures resulting from other causes including, but not limited to, failure of owner to provide normal maintenance and cleaning, normal weathering, or damage resulting from accident or casualty, fire, vandalism, wind-blown objects, structural defects, exposure to harmful chemicals, acts of God, or other such similar or dissimilar occurrences beyond the control of Z-FLEX. This product and the heating system(s) to which it is connected must also be inspected yearly by a qualified heating or venting technician. A written record (form on reverse side) of such inspections must be maintained by the homeowner and system deficiencies remedied and documented at the time of discovery.

To activate the warranty, the end-user must complete and return the attached Registration Card within sixty (60) days of installation of the venting system. Upon written notice of any defects, Z-FLEX reserves the right to verify compliance with the Z-FLEX Installation Instructions and examine or establish reasonable proof of defective material or workmanship justifying replacement.
