

Plastic Vent is it Warrantied

Unless certified to UL1738 or ULC-S636 Venting Systems Safety Standards, plastic pipe and fittings used as a flue gas venting system are NOT WARRANTIED. If your plastic vent system is ONLY certified to ASTM standards as a plumbing product and is used for purposes other than it's INTENDED, INSTRUCTED or certified purpose, there is NO WARRANTY.

This Limited Warranty will not apply if:

1) The Products are used for purposes other than their intended purpose as defined by local plumbing and building codes, and the applicable ASTM standard.
