

Installs in half the time. Simply cut to desired length and attach quick connect ends. No drilling or screwing required. Eliminates costly elbows and accessories.

- Cut to length on site, universal connectors
- 1 " clearance to combustibles, same as B-Vent
- For use with Category I appliances that are listed for use with Type B gas vent such as: furnaces, water heaters and boilers.

**Canada only:** National Code requires any atmospheric (Category I) gas fired appliance 77MBTU and under must have an insulated vent connector.


